

ATLANTA FALCONS SUPER BOWL SWEEPSTAKES
OFFICIAL RULES AND REGULATIONS
NO PURCHASE NECESSARY

WINNER MUST BE ABLE TO TRAVEL TO HOUSTON, TEXAS FEBRUARY 4-6TH, 2017 TO ENJOY PRIZE.

- 1. ELIGIBILITY. NO PURCHASE NECESSARY** to enter or win. The ATLANTA FALCONS SUPER BOWL SWEEPSTAKES (“Sweepstakes”) is open to legal residents of the state of Georgia and the US, who are at least 21 years of age and reside within 120 miles of the Georgia Dome. Employees and their immediate families (spouses, siblings, children, household members and the spouses and children of the foregoing) of Atlanta Falcons Football Club, LLC (the “Falcons”), Atlanta Falcons Stadium Company, LLC (“MBS”) the NFL Entities (defined as National Football League and its other member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Enterprises LLC, NFL Productions LLC, NFL International LLC and each of their respective parent companies, affiliates, subsidiaries, directors, officers, representatives, shareholders, and employees) and each of their respective parents, subsidiaries, and affiliated entities employees and each of their respective families (spouses, siblings, children, household members and the spouses and children of the foregoing) (collectively, the “Sweepstakes Entities”) are not eligible to enter the Sweepstakes. By entering the Sweepstakes, participants agree to accept and be bound by all terms of these Official Rules and Regulations. - 3. HOW TO ENTER.** Sweepstakes runs from **January 22, 2017 at 6:00 p.m. EST until January 30, 2017 at 11:59 p.m. EST (the “Entry Period”)**. During the Entry Period, eligible individuals can visit atlantafalcons.com/FalconsSuperBowlSweeps and follow the link to enter the Sweepstakes. Entrants will need to enter their name, phone number, and email address and consent to having read the Official Rules. Free Internet access is available at many public libraries. Any potential winners may be required to provide Sponsors with proof that he/she is the authorized account holder of the email address associated with the winning entry. No mechanical reproductions or facsimiles accepted. Sponsors are not responsible for misdirected, incomplete, lost, late or illegible entries, technical, hardware or software failures of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer, tablet or phone transmissions or other errors or problems which may limit a participant’s ability to participate in the Sweepstakes or damage to a user’s system, tablet or phone as a result of participation in the Sweepstakes or downloading of any information necessary to participate in the Sweepstakes. False or deceptive entries or acts, as determined by Sponsors in their sole

discretion, will render the entrant ineligible. Sponsors reserve the right, in their sole discretion, to cancel or modify the Sweepstakes should any computer virus, malfunction or other cause beyond their control corrupt the administration, security or proper operation of the Sweepstakes. All entries become the property of Sponsors and will not be returned. **LIMIT ONE ENTRY PER PERSON.** Attempts to enter the Sweepstakes more than once may disqualify all entries from the entrant in the sole discretion of Sponsors.

4. **HOW TO WIN.** One (1) Grand Prize Winner will be selected, by random drawing conducted by representatives from Sponsors from all the eligible entries received. The odds of winning will be determined by the number of eligible entries received. Sweepstakes will be administered by the Sponsors, the decisions of which in all matters regarding the Sweepstakes are final and binding. All winners are deemed potential winners until they have completed the Winner Documents and passed a background check in Sponsors' sole discretion, described below. The potential winners will be notified via email and must meet all eligibility requirements including the execution and delivery of all necessary releases. If a dispute arises regarding who submitted an entry, the entry will be deemed submitted by the holder of the email account associated with the entry as determined by Sponsors.

5. **PRIZES.** One (1) Grand Prize Winner will receive two (2) tickets to Super Bowl LI (the "Game") in Houston, Texas with an approximate retail value ("ARV") of \$2000, airfare for two (2) up to \$1000 or air transportation (as determined by Sponsors in their sole discretion) to Houston from Atlanta's Hartsfield-Jackson Airport and a hotel stay for one (1) room, double occupancy for two (2) nights in Houston (at a hotel determined by Sponsors in their sole discretion) with an ARV of \$1000. Total ARV of Grand Prize: \$4000. Transportation to/from airport and stadium is not included and is the sole responsibility of Winner and his/her guest. No weapons of any kind allowed. All costs, taxes, fees, and expenses associated with any element of any prize not specifically addressed above are the sole responsibility of the respective winner. Sponsor will not replace any lost, mutilated, or stolen tickets, vouchers, gift cards or certificates.

If any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.
